 - a. Review and/or approve December 8, 2020 meeting minutes.
 - Earnest Starling motioned for the December 8, 2021 meeting minutes to be accepted as read by City Secretary, Crystal Jenkins. Janeene Lucas seconds. Three for, zero against.
 - b. Review gas report.
 - i. Artis Anderson, gas supervisor, informs the council 3 new meters put in and one new customer. Gas truck is down. Asked if city is going to rent one or buy one. Mayor Ward responded by saying we can budget for an up-to-date truck. City and Gas System staff can start to look for a vehicle (preferably a 3 ¼ ton). Mr. Anderson stated that we can look for a truck without the utility box if need be because we can transfer the current box to the new vehicle. Those boxes cost \$5,000 to \$6,000. Mayor Ward stated that we need to stay in the range of 20 to 21, truck needs to be a Ford. Artis stated that truck can be a Ford or Chevy. Mr. Anderson asked if gas staff were to keep using their personal vehicles to run the gas and that he and Andrew can alternate by the week and keep track. Mayor Ward stated that the City would have to reimburse them for gas and that the City wants to ensure that we are handling this matter legally.
 - c. Review fire department report.
 - i. Larry Kellams, assistant fire chief of Easton VFD, informed the council that they have run on five calls, handled a wreck on HWY 149, ran two EMS calls and two structural fires. Talked to fellow at structural fire on Sawmill who said they are getting that site cleaned up. FD has run 12 calls for the year. Presented invoice for \$614.17 from Bobcat radio installation, parts, and labor for both FD vehicles.

Radios cover Gregg and Rusk County Sheriff's Office, Longview Dispatch and Rusk County Fire. Previous radios FD had received through donation were not strong enough. Mayor Ward thanked Mr. Kellams for getting that completed. Mr. Kellams informed council that Bobcat recommended that we get the alternators checked on the fire truck. He will check with a repair shop to see if they can look at the truck.
